3. Terms of reference

Trevor H outlined the reasons for forming this group in order to take on and advance the work started by the previous Naphill Common Committee which, it was confirmed, has now been formally wound up.

Our objectives will become better defined over the coming months but initially we can say: to preserve and restore the natural beauty of the Common, to arrange talks about and walks through the Common, to improve paths and signage, to open out scrub, conduct surveys and generally to care for and promote the use of the Common.

The Common is owned by Dashwood Estates and is a Site of Special Scientific Interest (SSSI) and we must take care to work with any restrictions Dashwood or Natural England place upon us at all times.

The group agreed on the name "Friends of Naphill Common".

The group is to be open to the whole village with as many people joining as possible. Membership fees were agreed at £5 per household. Members may get free walks, talks etc, others have to pay.

The group is to be managed by a Steering Group comprising all those attending this meeting, plus others who wish to join it. The affairs of the organisation shall be controlled by Committee.
